For organizing Solo or Group Exhibition at Raja Ravi Verma Art Gallery; SCZCC, Nagpur

1. **Objectives:** To promote art and artists of Member States of SCZCC in the field of visual art and crafts.
2. **Benefits:** a) SCZCC will provide Raja Ravi Verma Art Gallery for organizing solo or group exhibition for a limited period of time **FREE OF COST**.
 - b) SCZCC will also provide an honorarium to the artists as per details mentioned below.
 - i. Individual exhibitor from Nagpur – **Rs. 11,000/-**
 - ii. Group exhibitors from Nagpur – **Rs. 21,000/-** (minimum 5 artists).
 - iii. Individual exhibitor residing in any Member State of SCZCC except Nagpur – **Rs. 21,000/-**
 - iv. Group exhibitors residing in any Member State of SCZCC except Nagpur – **Rs. 51,000/-** (minimum 5 artists)
3. Artists, age above 18 years, hailing from any member States of SCZCC; namely: Maharashtra, Madhya Pradesh, Chhattisgarh, Andhra Pradesh, Telangana, Karnataka and Goa will only be considered. Please enclose domicile proof.
4. The form should be neatly filled and completed in all respects. No columns should be left unfilled. Typed nomination forms in the same format are also acceptable.
5. The application forms should be sent, at least one month in advance, to The Director, South Central Zone Cultural Centre, 56/1, Civil Lines, Opp MLA Hostel, Nagpur – 440001 (e-mail: sczccnagpur@gmail.com). 6. Director, SCZCC reserves all rights to allot or reject the booking without any notification and change of terms and conditions. In regards to the interpretation of any rule(s), the decision of the Director, SCZCC, will be final and binding to all. Hiding any kind of realities will result into disqualification, recovery if any and legal action.
7. The gallery will be given once in a year to the exhibitor subject to its availability and maximum for 10 days including installation and dismantling time.
8. The work(s) should be original creation of artists.
9. In case of loss or damage happening in the course of storage, transit, or display, SCZCC shall not be liable to any claim or legal pursuit. However, artist, if they so wish to deem fit, are at liberty to take an insurance coverage at their own cost.
10. Occupying gallery beyond the allotted period will invite penalty of **Rs. 1000/- per day** and forfeiture of honorarium.
11. Spoiling, damaging, altering gallery will invite penalty or cancellation of honorarium. Walls should not be nailed.
12. Timing of the exhibition will be 12 noon to 8 pm (all days, including Sundays and holidays). No entry tickets will be charged by the exhibitors.
13. The Centre will not provide TA/DA, transportation, lodging, boarding or any other type of assistance to the artist.
14. **The honorarium will be paid after receiving the completion report along with original copies of media coverage, photographs, CD/DVD, copy of invitation cards etc by the exhibitors. All financial transactions will be made through RTGS only and within 15 days after receiving the completion report from the exhibitor. The exhibitor is advised to submit completion report within 20 days after completion of exhibition. No claims of honorarium will be considered in case of delay in submission of completion report.**
15. The name/logo of SCZCC must be highlighted in all publicity material including invitation cards, banners, standees, pamphlets, handouts, press notes, social media and proof to be submitted to the office after completion of the exhibition. Logo is available at: www.sczcc.gov.in
16. Art works, to be displayed, should not be controversial, political, obscene, or vulgar in nature. The exhibitor will be responsible for any such issues.
17. SCZCC reserves the right to reproduce/publish the exhibit. Due credit will be given to the artists wherever possible.
